Based on the listing of certified MBE/WBE firms in your bid proposal along with the corresponding Letters of Intent, the Department has approved the following committed MBE/WBE firms and dollar amounts for a total of 0.61% participation:

1. Hickory Sealing and Striping, Inc.	\$ 18,216.00

These firms are required to be utilized under the regulations in the Minority Business Enterprise and Women Business Enterprise Special Provision as contained in the contract. Any changes in the work affecting a MBE/WBE firm or replacement of a MBE/WBE firm must follow the procedures in this provision. In accordance with Article 102-15(J) of the *NCDOT Standard Specifications*, failure to satisfy the MBE/WBE requirements of the project Special Provisions is cause for disqualifying a Contractor from further bidding.

**Your request for withdrawal of banked funds to meet the MBE/WBE participation goal shortfall has been approved.**

The MBE/WBE Goal Commitment of **0.61%** and the withdrawn banked funds in the amount of **\$101,749.71** will be the Contract Goal Requirements.

- A Certificate of Public Liability and Property Damage Insurance for the coverage as stated in Section 107-15 of the *Standard Specifications*. The Certificate must include the North Carolina Department of Transportation as an additional insured on the policy.
