- A Certificate of Public Liability and Property Damage Insurance for the coverage as stated in Section 107-15 of the *Standard Specifications*. The Certificate must include the North Carolina Department of Transportation as an additional insured on the policy.
- Two properly executed Non-Collusion Affidavit, Debarment Certification, and Execution of Bid Forms. These forms are available on the NCDOT website at: https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx

No further actions will be taken until requested documentation is received. No time extensions will be considered for delays in providing the requested documentation and for scheduling the Preconstruction Conference except as authorized by Section 108-10 of the *Standard Specifications*.
