The date of availability for this contract is May 1, 2025.

The completion date for this contract is **November 1, 2025**.

Except where otherwise provided by the contract, observation periods required by the contract will not be a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. The acceptable completion of the observation periods that extend beyond the final completion date shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are Nine Hundred Dollars (\$ 900.00) per calendar day.
