I am pleased to inform you that your firm has been awarded the contract for the above project based on the bid submitted on April 20, 2023, in the amount of \$3,997,115.66. Your bid proposal **did not** indicate adequate participation to satisfy the advertised Combined **MBE/WBE Goal** of **5.0%**.

Your request for the withdrawal of \$63,205.78 of banked funds to meet the shortfall has been approved.

Based on your bid proposal along with the corresponding Letters of Intent, and the withdrawn Banked Funds, the Department has approved the following committed MBE/WBE firms and dollar amounts to meet the Contract Goals:

the MBE/WBE requirements of the project Special Provisions is cause for disqualifying a Contractor from further bidding.

- A Certificate of Public Liability and Property Damage Insurance for the coverage as stated in Section 107-15 of the *Standard Specifications*. The Certificate must include the North Carolina Department of Transportation as an additional insured on the policy.
