All prospective bidders at the Mandatory Pre-Bid Conference shall meet all of the requirements as shown below:

- 1. Only Bidders who have attended the entire conference and properly registered at the Mandatory Pre-Bid Conference will be considered eligible to bid on this project. A bid received from a Bidder who has not attended and properly registered at the conference will be rejected, considered an irregular bid, and will not be considered for award.
