All routes shall be mowed to the satisfaction of County Maintenance Engineer. Decisions regarding re-mowing of routes or portions thereof are the responsibility of the Engineer and his decision shall be final. Any routes or portions requested to be re-mown by the Engineer will be done so at no further expense to the department.

The Contractor is advised that there are no guaranteed minimum quantities and this should be considered prior to bid submittal.

Any routes that require a "Full Lane Closure" shall be discussed and approved by the County Maintenance Engineer prior to the work being performed.

## Equipment

The Contractor shall furnish all equipment in good operating condition and operated by properly trained and qualified personnel. The Contractor shall be responsible for all costs or charges incurred in the operation and maintenance of the equipment during the performance of this contract.

The equipment required to perform the work in this contract shall be a tractor of sufficient size and shall a horsepower rating of 100 HP or greater. It shall contain a mowing deck of at least five (5) feet in width and have a minimum reach of twenty (20) feet.

NOTE: The bidder shall attach to his bid a complete description of the equipment which he plans to use to accomplish the work. This description shall include the horsepower of the tractor(s), model, year, reach and mowing deck size.

## Method of Payment

Payment for the work covered under this provision will be paid for as the actual number of Shoulder Miles as measured to the nearest one-tenth (.10) mile. There will be four separate pay items based on the type of route in which the work is performed.

Payment will be made under the following items:
