Based on the listing of certified MBE/WBE firms in your bid proposal along with the corresponding Letters of Intent, the Department has approved the following committed MBE/WBE firms and dollar amounts to meet the Contract Goals:

These firms are required to be utilized under the regulations in the Minority Business Enterprise and Women Busines Enterprise Special Provision as contained in the contract. Any changes in the work affecting a MBE/WBE firm or replacement of a MBE/WBE firm must follow the procedures in this provision. In accordance with Article 102-15(J) of the *NCDOT Standard Specifications*, failure to satisfy the MBE/WBE requirements of the project Special Provisions is cause for disqualifying a Contractor from further bidding.

Prior to execution of the contract by the Department, the following items must be received in **this office** within fourteen (14) calendar days and no work may be performed on this project until such time as the contract has been properly executed:

- Two (2) original sets of Payment Bonds and Performance Bonds, each with accompanying Power of Attorney, in the amount of \$530,261.76. These forms are available on the NCDOT website at: https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx
- A Certificate of Public Liability and Property Damage Insurance for the coverage as stated in Section 107-15 of the *Standard Specifications*. The Certificate must include the North Carolina Department of Transportation as an additional insured on the policy.
- Two properly executed Non-Collusion Affidavit, Debarment Certification, and Execution of Contract Forms. These forms are available on the NCDOT website at: https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx

No further actions will be taken until requested documentation is received. No time extensions will be considered for delays in providing the requested documentation and for scheduling the Preconstruction Conference except as authorized by Section 108-10 of the *Standard Specifications*.

In addition, your attention is directed to Articles 107-15, 108-1, 108-2 and 108-3 of the *Standard Specifications* relative to liability insurance, prosecution of work, progress schedule and preconstruction conference.
