The intermediate completion date for this project is **April 30, 2015**.

All prospective bidders at the Mandatory Pre-Bid Conference shall meet all of the requirements as shown below:

- 1. Only Bidders who have attended the entire conference and properly registered at the Mandatory Pre-Bid Conference will be considered eligible to bid on this project.
