The following revision has been made to the Contract Proposal:

Page G-3 – **INTERMEDIATE CONTRACT TIME NUMBER 2 AND LIQUIDATED DAMAGES**, has been revised. This revision corrected the day and time restrictions for maps 5, 6, and 7. The day and time restrictions have been revised to read 'Monday thru Sunday from 6:00 AM to 7:00 PM' to reflect the intended nighttime work requirement. Please replace Page G-3 in you contract proposal with the **revised Page G-3** attached to this addendum letter.

This revision is reflected in the Proposal currently posted on the Division 11 Letting Page.

- 2. For New Year's Day, between the hours of 3:00 P.M. December 31st and 8:30 A.M. January 2nd. If New Year's Day is on a Friday, Saturday, Sunday or Monday, then until 8:30 A.M. the following Tuesday.
- 3. For Easter, between the hours of **3:00 P.M.** Thursday and **8:30 A.M.** Monday.
- 4. For **Memorial Day**, between the hours of **3:00 P.M.** Friday and **8:30 A.M.** Tuesday.
- 5. For **Independence Day**, between the hours of **3:00 P.M.** the day before Independence Day and **8:30 A.M.** the day after Independence Day.

If **Independence Day** is on a Friday, Saturday, Sunday or Monday, then between the hours of **3:00 P.M.** the Thursday before Independence Day and **8:30 A.M.** the Tuesday after Independence Day.

- 6. For Labor Day, between the hours of **3:00 P.M.** Friday and **8:30 A.M.** Tuesday.
- 7. For **Thanksgiving Day**, between the hours of **3:00 P.M.** Tuesday and **8:30 A.M.** Monday.
- 8. For **Christmas**, between the hours of **3:00 P.M.** the Friday before the week of Christmas Day and **8:30 A.M.** the following Tuesday after the week of Christmas Day.

Holidays and holiday weekends shall include New Year's, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas. The Contractor shall schedule his work so that lane closures will not be required during these periods, unless otherwise directed by the Engineer.

The time of availability for this intermediate contract work shall be the time the Contractor begins to install all traffic control devices for lane closures according to the time restrictions listed herein.

The completion time for this intermediate contract work shall be the time the Contractor is required to complete the removal of all traffic control devices for lane closures according to the time restrictions stated above and place traffic in the existing traffic pattern.

The liquidated damages are **One Thousand One Hundred Dollars (\$ 1,100.00)** per hour.

INTERMEDIATE CONTRACT TIME NUMBER 2 AND LIQUIDATED DAMAGES: (2-20-07) 108 SP1 G14 C

The Contractor shall complete the required work of installing, maintaining and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on MAPS 5, 6, and 7 during the following time restrictions:

DAY AND TIME RESTRICTIONS

Monday thru Sunday from 6:00 AM to 7:00 PM
