Reference is made to the Contract Proposal recently furnished to you on the above-mentioned project. The following revisions have been made to the Contract Proposal:

TABLE OF CONTENTS, has been modified to reflect the revisions included in this addendum.

Pages G-1, R-2, R-3, R-6, have been revised. All text of *Launched Soil Nails* has been removed from these pages.

Pages R-2 thru R-3, CONTRACTOR QUALIFICATIONS, have been revised. This revision changed the requirement to have the capability to work on 'up to 3 sites' within a timely manner to requiring the capability to work on 'multiple' sites within a timely manner. This revision, therefore, removed the requirement for 'three individuals' on items 2 thru 5 under this provision.

Pages R-6 thru R-11, LAUNCHED SOIL NAILS Special Provision has been removed.

Pages R-16 thru R-17, GEOSYNTHETICALLY CONFINED SOIL WALLS, has been revised. This revision removed Geosynthetically Confined Soil Walls and added Geosynthetically Reinforced Soil Retaining Walls.

BID FORM, has been revised. Launched Soil Nails, original item #5, has been removed. Geosynthetically Confined Soil Wall, original item #41, has been removed. Geosynthetically Reinforced Soil Retaining Wall, new item #40, has been added.
