Page 1-65, Article 108-5 Character of Workmen, Methods, and Equipment, line 32, delete all of line 32, the first sentence of the second paragraph and the first word of the second sentence of the second paragraph.

CONTRACT BID QUANTITIES

The quantities shown in the itemized proposal for the project are considered to be approximate only and are given as the basis for comparison of bids. The Department of Transportation may increase or decrease the quantity of any item or portion of the work as may be deemed necessary or expedient.

An increase or decrease in the quantity of any item will not be regarded as sufficient ground for an increase or decrease in the unit prices, nor in the time allowed for the completion of the work, except as provided for the contract.

Contractor's pricing shall be based on the estimated quantities per Division. These estimated amounts are submitted to assist contractors in the bidding process. Estimated quantities are not to be regarded as actual requirements. The State shall not be obligated to purchase any specific quantity.

SUBSURFACE INFORMATION

There is no subsurface information available on this project. The Contractor shall make his own investigation of subsurface conditions.

CLEARING AND GRUBBING

The work covered by this section shall include the removal of trees that have been previously felled by NCDOT forces and the grubbing of associated stumps and undergrowth in accordance with Section 200 of *Standard Specifications*. These actions are necessitated by the possible presence of the Virginia Long-Eared Bat species and associated moratorium on tree removal imposed by the regulatory agencies.

All trees located within the construction limits of this project will be felled by NCDOT forces and left on site prior to the beginning of this project. Any timber that has been requested by a property owner will be removed by NCDOT and placed outside of the construction limits. Any felled, unclaimed timber and/or limbs not previously claimed will remain within the construction limits and will be the responsibility of the contractor for removal and disposal. No grubbing of the stumps and no land disturbing activities will be performed by NCDOT forces on this project.

Compensation for the removal and disposal of the felled trees and the grubbing of the remaining stumps will be included under the pay item for Grading and will be paid for at the contract lump sum price. No further compensation will be made.

AGGREGATE PRODUCTION

Provide aggregate from a producer who uses the current Aggregate Quality Control/Quality Assurance Program, which is in effect at the time of shipment.

No price adjustment is allowed to contractors or producers who use the program. Participation in the program does not relieve the producer of the responsibility of complying with all requirements of the *Standard Specifications*. Copies of this procedure are available upon request from the Materials and Test Unit.
