 - o Burden lies with designer to verify and conduct outreach to potential contractors.
 - o Bonnie offered assistance with contacting potential minority subcontractors.
 - Exclusion of minority participation does not disqualify potential bidders for informal contractors. Minority participation forms are not included for informal construction projects and are not required to be submitted.

Bid Questions and Answers:

Q: Length of contract is currently set to 30 days; can contract be extended to accommodate material submittals?

- A: Due to time constraints with this project the advertised 30 day contract timeframe will remain. The submittal process for a project of this scale should only require 1-2 days to turn around. Should NCDOT staff cause an undue delay in review of submittals, contractor may submit a claim for extension of the project.
 Q: Will lack of minority participation disqualify a bid?
 A: For informal contracts, the burden of minority participation lies with the designer
- and the State. Lack of minority participation will not disqualify any bidders.

Additional Information

Bid opening is scheduled for 3:00pm on Thursday November 14, 2013. Bidders must have sealed bids delivered by 3:00pm, any bid received after that time is considered non-responsive. Bids may be delivered by any means the contractor wishes, but the State is not responsible for delays in delivery.
