In accordance with Article 102-15(J) of the *NCDOT Standard Specifications*, failure to satisfy the MBE/WBE requirements of the project Special Provisions is cause for disqualifying a Contractor from further bidding.

Prior to execution of the contract by the Department, the following items must be received in **this office** within fourteen (14) calendar days and no work may be performed on this project until such time as the contract has been properly executed:

- Two (2) original sets of Payment Bonds and Performance Bonds, each with accompanying Power of Attorney, in the amount of \$4,114,283.96. - A Certificate of Public Liability and Property Damage Insurance for the coverage as stated in Section 107-15 of the *Standard Specifications*. The Certificate must include the North Carolina Department of Transportation as an additional insured on the policy.
- Two properly executed Non-Collusion Affidavit, Debarment Certification, and Execution of Bid Forms.
