An increase or decrease in the quantity of an item will not be regarded as sufficient ground for an increase or decrease in the unit prices, nor in the time allowed for the completion of the work, except as provided for the contract.

All bids shall be prepared and submitted in accordance with the following requirements. Failure to comply with any requirement may cause the bid to be considered irregular and may be grounds for rejection of the bid.

#### TRADITIONAL PAPER BIDS:

- **1.** Download the entire proposal from the Connect NCDOT website and return the entire proposal with your bid.
- 2. In accordance with Article 102-3 of the *Standard Specifications*, registration on the Interested Parties List is required unless SP1 G02 Interested Parties List Not Required provision is included in the proposal.
- 3. All entries on the itemized proposal sheet (bid form) shall be written in ink or typed.
- 4. The Bidder shall submit a unit price for every item on the itemized proposal sheet. The unit prices for the various contract items shall be written in figures. Unit prices shall be rounded off by the Bidder to contain no more than FOUR decimal places.
- **5.** An amount bid shall be entered on the itemized proposal sheet for every item. The amount bid for each item shall be determined by multiplying each unit bid by the quantity for that item, and shall be written in figures in the "Amount" column of the form.

# **GENERAL**

## AWARD OF CONTRACT - SMALL BUSINESS ENTERPRISE PROGRAM

Bids are being solicited for this project under the provisions of the NCDOT's Small Business Enterprise Program in accordance with *NCGS 136-28.10*.

Your firm does not have to be formally identified as a minority, woman or disabled owned business to qualify for this program, but you must have had an annual gross income of \$1.5 million or less, exclusive of materials, for the previous calendar year.

The maximum yearly contract limit is set at \$1,000,000. If the total bid amount of the contract exceeds this amount, the bid will not be considered for award. The maximum yearly contract value for all renewals cannot exceed \$1,000,000 per year.

Work shall be accomplished in a continuous manner once the contractor begins.

Any liquidated damages for this contract will be assessed per the Mobilization and Liquidated Damages provision located elsewhere in this Contract.

Work orders will be assigned by the Engineer. The Contractor shall respond to the work order assignments with the anticipated start date, within three working days of notification unless noted otherwise. Failure to complete work in accordance with contract provisions and completion date may result in liquidated damages.

For federal ID/IQ contracts, all work orders will be assigned via the Work Order Assignment Form (Form IDIQ-1SA), and the Contractor is required to formally respond in writing for federal work orders within three working days, unless noted otherwise. The Work Order Assignment Form will also be used for any state ID/IQ contract in which the estimated work order cost meets the threshold for Performance and Payment Bonds in accordance with the Bonding Requirements for ID/IQ provision found elsewhere in this contract. For state ID/IQ contracts in which the work order assignment doesn't meet the threshold for bonds, the Department has the option to use the Work Order Assignment Form or other methods for work order assignments as agreed upon by the Engineer and Contractor.

The Contractor shall be required to prosecute the work in a continuous and uninterrupted manner from the time they begin the work until completion and final acceptance of the work order. Multiple failures of the Contractor to mobilize and begin work on the work order within the agreed upon time frame or failure to complete the work within the given time frame may result in the Contractor being excluded from future work on this contract in accordance with the *Standard Specifications*.

## **BONDING REQUIREMENTS FOR ID/IQ:**

For purposes of this ID/IQ contract, the following definitions apply:

Project Agreement: A transportation improvement with a defined scope of work; a written agreement between NCDOT and the Federal Government defining the extent of construction work to be undertaken in accordance with the submitted plans, specifications and estimates. Execution of the agreement prompts the authorization to proceed (construction funding).

Project: An undertaking issued to a contractor through a Work Order Assignment. The construction under a Project Agreement may be accomplished by one or more work order assignments, from one or more ID/IQ contracts. Note that for ID/IQ contracts this definition supersedes the definition in the Standard Specifications.

Award: The issuance of a signed Work Order Assignment by NCDOT shall constitute the notice of award of a project.

In accordance with North Carolina General Statute 44A-26, bonds are required on contracts awarded for any one project that exceeds \$500,000. Beyond statutory requirements, NCDOT policy requires payment and performance bonds on all projects where the engineer's estimate is \$450,000 or greater, all Asphalt Surface Treatment projects, and projects containing the 12-month guarantee provision. The limit for waiving bonds for all bridge replacement and major bridge rehabilitation projects (latex overlays, etc.) is \$300,000 based on the engineer's estimate. The decision of bonding of a work order assignment below the dollar amounts listed shall be at the discretion of the Division's evaluation of the risks associated with the project.

The need for contract payment and performance bonds will be determined at the Work Order Assignment level. The Work Order Assignment will notify the Contractor of an award of a project and if required, to provide contract payment and performance bonds per Article 103-7 of the *Standard Specifications*. The Work Order Assignment replaces the Notification of Award Letter mentioned in Article 103-4(A) of the *Standard Specifications*.

The Contractor shall submit a bid for one year. At the option of the Department, this contract may be extended for two (2) additional periods of one year each (maximum (3) three years total). Each year shall have a limit of **one million dollars** (**\$1,000,000**).

The compensation payable to the contractor shall be fixed for the first twelve months of this contract. However, upon an application of renewal of the contract, or thirty days prior to the end of each contract period, the renewal contract may be adjusted to reflect the adjustment in the Consumer Price Index over the latest twelve month period as published by the US Bureau of Labor and Statistics at http://www.bls.gov/cpi to be applied to new work order assignments. The Consumer Price Index for All Urban Consumers (CPI-U), US City Average, All Items, 1982-84=100, not seasonally adjusted will be used. If the amount of the requested adjustment is more than ten percent, the Department of Transportation reserves the right to cancel this contract.

CPI adjustment values can be determined using the calculator on the NCDOT Construction website.

This price escalation method will not be applied to items of work that are separately covered under commodity price escalation clauses. No other changes in the terms, conditions, etc. of this contract will be made when an extension to the contract is implemented. The Engineer will notify the Contractor in writing **60** days prior to the contract end date if the contract may be extended. The Contractor must notify the Engineer in writing within **30** days of receiving the contract extension offer of his acceptance or rejection of this offer. Failure on the part of the Contractor to reply will be received as a rejection of contract extension. **The Department is under no obligation to renew this contract beyond the original 1 year term.** 

#### **DISPUTE RESOLUTION PROCESS FOR ID/IQ:**

If a question should arise on the contract or assignment of a work order, the contractor should notify the Engineer noted on the assignment documentation or the Division Engineer within 48

hours after the scheduled time of bid opening or work order assignment. The following should be included in the notification if applicable:

- (A) the contract for which bids were solicited;
- (B) the particular law, regulation, or contract specification violated;
- (C) a detailed description of the alleged violation; and
- (D) any other information deemed to be relevant.

Once the initial evaluation has been completed, the contractor may be asked to attend a meeting for further discussion and clarification.

Once a determination has been made, the contractor will be notified of the decision by the Division Engineer. If the decision does not meet the satisfaction of the contractor, they have 24 hours from the Division Engineer's notification to elevate the dispute to the Chief Engineer. The Chief Engineer will make the final decision and will not be subject to further review by NCDOT.

The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on **ANY NON-INTERSTATE ROUTE** during the following time restrictions unless otherwise directed by the Engineer:

# MONDAY THRU FRIDAY 6:00 A.M. TO 9:00 A.M. 4:00 P.M. TO 7:00 P.M.

In addition, the Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on **INTERSTATE ROUTES** during the following time restrictions or as directed by the Engineer:

# **INTERSTATE DAY AND TIME RESTRICTIONS**

# MONDAY THRU SUNDAY 6:00 A.M. TO 9:00 P.M.

In addition, the Contractor shall not narrow or close a lane of traffic on **ANY ROAD**, detain and /or alter the traffic flow on or during holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

#### HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

1. For **unexpected occurrence** that creates unusually high traffic volumes, as directed by the Engineer.

- 2. For New Year's Day, between the hours of 7:00 AM December 31st and 7:00 PM January 2nd. If New Year's Day is on a Friday, Saturday, Sunday or Monday, then until 7:00 PM the following Tuesday.
- 3. For **Easter**, between the hours of **7:00 AM** Thursday and **7:00 PM** Monday.
- 4. For **Memorial Day**, between the hours of **7:00 AM** Friday and **7:00 PM** Tuesday.
- 5. For **Independence Day**, between the hours of **7:00 AM** the day before Independence Day and **7:00 PM** the day after Independence Day.

If **Independence Day** is on a Friday, Saturday, Sunday or Monday, then between the hours of **7:00 AM** the Thursday before Independence Day and **7:00 PM** the Tuesday after Independence Day.

- 6. For Labor Day, between the hours of **7:00 AM** Friday and **7:00 PM** Tuesday.
- 7. For **Thanksgiving Day**, between the hours of **7:00 AM** Tuesday and **7:00 PM** Monday.
- 8. For **Christmas**, between the hours of **7:00 AM** the Friday before the week of Christmas Day and **7:00 PM** the following Tuesday after the week of Christmas Day.

Holidays and holiday weekends shall include New Year's, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas. The Contractor shall schedule his work so that lane closures are not required during these periods, unless otherwise directed by the Engineer.

The time of availability for this intermediate contract work shall be the time the Contractor begins to install all traffic control devices for lane closures according to the time restrictions listed herein.

The completion time for this intermediate contract work shall be the time the Contractor is required to complete the removal of all traffic control devices for lane closures according to the time restrictions stated herein and place traffic in the existing traffic pattern.

The liquidated damages are **Five Hundred Dollars** (**\$ 500.00**) per hour.

#### **EQUIPMENT IDLING GUIDELINES:**

Exercise reduced fuel consumption and reduced equipment emissions during the construction of all work associated with this contract. Employees engaged in the construction of this project should turn off vehicles when stopped for more than thirty (30) minutes and off-highway equipment should idle no longer than fifteen (15) consecutive minutes.

These guidelines for turning off vehicles and equipment when idling do not apply to:

- 1. Idling when queuing.
- 2. Idling to verify the vehicle is in safe operating condition.
- 3. Idling for testing, servicing, repairing or diagnostic purposes.
- 4. Idling necessary to accomplish work for which the vehicle was designed (such as operating a crane, mixing concrete, etc.).
- 5. Idling required to bring the machine system to operating temperature.
- 6. Emergency vehicles, utility company, construction, and maintenance vehicles where the engines must run to perform needed work.
- 7. Idling to ensure safe operation of the vehicle.
- 8. Idling when the propulsion engine is providing auxiliary power for other than heating or air conditioning. (such as hydraulic systems for pavers)
- 9. When specific traffic, safety, or emergency situations arise.
- 10. If the ambient temperature is less than 32 degrees Fahrenheit. Limited idling to provide for the safety of vehicle occupants (e.g. to run the heater).

# **ROADWAY**

# TREE & BRUSH CUTTING / TRIMMING TREE OR BRUSH CUTTING AND REMOVAL:

All work performed by the Contractor shall be in compliance with the current North Carolina Department of Transportation <u>Standard Specifications for Roads and Structures</u>, specifically Section 200-3, "Clearing Operations", with all workmanship and general appearances being performed to the satisfaction of the Engineer or designee.

The Contractor will be required to cooperate with State Forces and other contractors within the limits of any assigned project as directed by the Engineer or designated job site supervisor.

Failure to provide an adequate amount of personnel and/or equipment on the actual job site will likely result in suspension of the Contractor's services until all items are in compliance, and as related to Prosecution of Work.

The Contractor shall perform the work of tree or brush cutting and removal along secondary and primary routes between the right-of-way clearing limits in all cut and fill areas or as directed by the Engineer, except in environmentally sensitive areas. In environmentally sensitive areas leave a fifty (50') foot buffer around the area. Trees in these areas shall be limbed only unless deemed a hazard by the engineer. Only in hazardous situations will trees be allowed to be removed.

Treat stumps with a herbicide within a 24 hour period after cutting to prevent sprouting. This method is utilized where brush/trees are cut back, normally to ground level, and a systemic herbicide solution is applied directly to the cut surface.

During clearing operations the Contractor shall use hand tools i.e. chainsaws, bush axes, etc. to **cut trees or brush as close to natural ground as possible** in the clearing operations. Bush hogs and other mechanical clearing equipment may only be used with prior approval of the Engineer. The Engineer will designate which trees to remove by diameter and type.

# The Contractor shall not cut Dogwood Trees or Redbud Trees. The Engineer will specify any other tree types that may be excluded from a project area.

During maintenance operations when directed by the Engineer, the Contractor will grind the stumps of felled trees to a depth of 6" below the ground level. Mulch created by grinding of the stump shall be raked down or removed, as directed by the Engineer, to blend and level the area to a uniform contour that matches the surrounding topography. Seeding & mulching of the disturbed area, if required, will be performed by State Forces.

Chainsaws shall be commercial grade, gasoline powered units with a minimum bar length of 18". All original equipment safety devices shall be in place. The Engineer may reject any equipment that is not operating in a satisfactory manner.

Vehicle and chipper operators shall possess the appropriate licenses and skills for the equipment used. Equipment shall be in good working order and all safety devices shall be in place. Workers shall wear an ANSI compliant Class III safety vest, closed-toe shoes, shirts with sleeves and long pants, vision and hearing protection, and shall not wear any loose clothing or jewelry. Vests may be removed when feeding material into chipper.

Wood chips shall become the property of the contractor. Upon approval by the Engineer, chips may be dispersed within the highway right-of-way if they do not interfere with drainage structures, site distances, or turf growth.

Any damage to adjacent and/or personal property including windshields, fences, signs, pavement and or alleged thrown rocks due to Contractor's negligence shall be replaced or repaired by the Contractor to the satisfaction of the Engineer.

Any work performed in an unsatisfactory manner could be basis for cancellation of the contract.

The Contractor shall discuss each project with the Engineer or designated job site representative prior to the commencement of work. At that time the Engineer will specify the type of work to be performed.

# **HERBICIDE TREATMENT:**

Treat stumps with a herbicide immediately after cutting to prevent sprouting. Follow all applicable instructions, warnings, and safety precautions stated on the manufacturer's label, and comply with all laws and regulations governing herbicides that are in effect at the time of use. Apply all herbicides in accordance with the manufacturer's instructions on the product label. Broadcast spraying will not be allowed.

Use an herbicide with blue dye which has been approved by the Division Roadside Environmental Engineer. The Division Roadside Environmental Engineer will also approve the application equipment and the method of application. The Roadside Environmental Engineer can be reached at 704-480-5650. Properly registered herbicides for stump treatment to prevent regrowth are listed on pages 461-462 of the 2011 NC Agricultural Chemicals Manual located at: <a href="http://ipm.ncsu.edu/agchem/8-toc.pdf">http://ipm.ncsu.edu/agchem/8-toc.pdf</a>.

Herbicides shall be properly labeled and registered with the United States Department of Agriculture and the North Carolina Department of Agriculture. A container shall contain only the herbicide that meets the analysis guaranteed on the label. Keep all herbicides in such original labeled containers until used.

Herbicide application shall be conducted by individuals who possess the appropriate applicator's license from the NC Department of Agriculture or individuals under their direction and understands, and follows the herbicide labeling before applying the product. Licensed applicators

shall submit a copy of their license to the Division Roadside Environmental Engineer for his approval prior to beginning work.

No direct payment will be made for herbicide treatment as it is considered incidental to all stumps in the tree cutting and brush clearing operation.

<u>Guarantee</u>: The understood goal of Herbicide Treatment of cut-stumps on this contract is to achieve 100% control. NCDOT expects, and will hold the successful contractor to a 95% treatment guarantee after the initial application. If this is not achieved, the contractor/applicator agrees to return and retreat the area to insure the desired results are achieved at no additional cost to NCDOT.

# MINOR / MAJOR CLEARING:

Clearing of trees and brush, typically larger than four (4) inches diameter, in an area less than one (1) acre (Minor Clearing) or an area greater than one (1) acre (Major Clearing) may be required at certain locations as directed by the Engineer. The Contractor shall use hand tools i.e. chainsaws, bush axes, etc. to **cut trees or brush as close to natural ground as possible** in the clearing operations. Bush hogs and other mechanical clearing equipment may only be used with prior approval of the Engineer. Treat stumps with herbicide immediately after cutting to prevent sprouting. This method is utilized where brush/trees are cut back, normally to ground level, and a systemic herbicide solution is applied directly to the cut surface. Removal of any debris shall be the responsibility of the Contractor.

Payment for minor clearing or major clearing will be at the contract unit price per acre for the items *Minor Clearing* or *Major Clearing*. Payment for minor or major clearing shall be considered full compensation for all labor, materials, equipment and incidentals required to perform the work.

Felled Tree Removal shall be performed in accordance with accepted industry practices. Removal of any debris shall be the responsibility of the Contractor.

Payment for Felled Tree Removal will be at the contract unit price per each for the item *Felled* Tree Removal. Payment for felled tree removal shall be considered full compensation for all labor, materials, equipment and incidentals required to perform the work.

# **HAZARDOUS TREE REMOVAL:**

Removal of a single hazardous tree may be required at certain locations as directed by the Engineer where there may be a dead, dying, or leaning tree that is likely to fall on the highway, or may be causing problems with sight distance. Hazardous tree removal shall be performed in accordance with accepted industry practices. Removal of any debris shall be the responsibility of the Contractor.

Payment for hazardous tree removal will be at the contract unit price per each for the item Payment for hazardous tree removal shall be considered full Hazardous Tree Removal. compensation for all labor, materials, equipment and incidentals required to perform the work.

Hazardous tree trimming or pruning may be performed manually and/or mechanically in accordance with accepted industry practices. Removal of any debris shall be the responsibility of the Contractor.

# **STUMP GRINDING:**

Grinding of stumps may be required at certain locations as directed by the Engineer. Stumps shall be ground in accordance with accepted industry practices to a depth of six (6) inches below the elevation of the surrounding surface area. Removal of any debris shall be the responsibility of the Contractor. The Contractor shall be notified in advance if stump grinding is required.

Payment for stump grinding and removal of debris will be at the contract unit price per diameter inch for the item *Stump Grinding* measured across the largest diameter of stump surface area. Payment for stump grinding shall be considered full compensation for all labor, materials, equipment and incidentals required to perform the work.

#### **EROSION CONTROL:**

The Contractor shall exercise every reasonable precaution throughout the life of the project to prevent erosion and siltation. In the event that the Contractor's operations create erodible surfaces, the Contractor shall install appropriate erosion control devices as determined by the Engineer.

Erosion Control devices may include but shall not be limited to Silt Fence, Erosion Control Stone and Sediment Control Stone.

No direct payment shall be made for erosion control items or installation, as they shall be considered incidental to other contract items.

# **CONTRACTOR:**

<u>Supervision</u> - At all times that work is actually being performed, the Contractor shall have available on the project one competent individual who has been authorized to act in a supervisory capacity

over all work. In the event a project is clustered and consists of two or more counties, a supervisor may be required for each county, as the Engineer may consider necessary. The individual who has been so authorized shall be experienced in the type of work being performed and is to be fully capable of managing, directing, and coordinating the work; of reading and thoroughly understanding the contract; and of receiving and carrying out directions from the Engineer or his authorized representatives.

<u>Personnel</u> - The Contractor shall provide qualified and trained personnel capable to satisfy all the requirements of this contract. The Contractor is to make a review of the contract requirements for work included herein and in conjunction with actual job site conditions. While on duty, Contractor's personnel shall work consistently on the duties as described herein.

<u>Prosecution of Work</u> - The Contractor will be notified by the Engineer as to when to begin operations, and the Contractor shall begin work within two (2) working days after being notified. Any work performed prior to the time of notification by the engineer will not be included in any payment to the Contractor. The Contractor will be required to prosecute the work in a continuous and uninterrupted manner.

<u>Operation of Equipment</u> - The Contractor shall operate the equipment in a safe manner so as not to create a hazard to the traveling public. The equipment shall not be parked within the State Highway System right of way overnight or at other times when work has been suspended, unless approved by the Engineer. Mowers shall be equipped with shields, which preclude foreign objects from being thrown from the cutting enclosures.

All of the Contractor's equipment must have their Company's logo and telephone number on each piece of equipment used on this project.

<u>Responsibility for Damage Claims</u> - The Contractor shall indemnify and save harmless the Department of Transportation and its officers, agents, and employees from all suits, actions or claims by any character brought for any injury or damages received or sustained by any person, persons, or property by reason of any act of the Contractor, its agents or employees, in the performing of the contract.

<u>Protection and Restoration of Property</u> - The Contractor shall be responsible for the protection from his activities of all public and private property on and adjacent to the work and shall use every reasonable precaution necessary to prevent damage or injury thereto. He shall use suitable precautions to prevent damage to signs, fences, poles, wires, cables, and other overhead structures.

The Contractor shall protect carefully from disturbance or damage all land monuments and property markers.

The Contractor will be held responsible for all damage or injury to property of any character resulting from any act, omission, negligence, or misconduct in the prosecution of the work. When any direct or indirect damage or injury is done to public or private property by or on account of any act, omission, negligence, or misconduct in the execution of the work, he shall either restore at his own expense such property to a condition similar or equal to that existing before such damage or injury was done, or shall make good such damage or injury in a manner acceptable to the owner of the damaged property and to the Department. In case of failure on the part of the Contractor to restore such property or make good such damage or injury the Department may at the Contractor's

expense repair, rebuild, or otherwise restore such property in such manner as the Engineer may consider necessary.

The safety of the public and the convenience of traffic shall be regarded as prime importance.

# **DEADHEADING GUIDELINES:**

In order to have an effective safety program and reduce accidents and occupational illnesses, each person must be responsible for safety. All employees are expected to take an active role in the safety program and its associated policies. These guidelines are a supplement to our Workplace Safety Manual.

The purpose of these Deadheading Guidelines is to aid Division Twelve personnel in the effective implementation of these safety procedures in regard to Deadheading equipment. *Deadheading should be avoided altogether whenever possible.* Deadheading often exposes personnel to unnecessary hazards and causes unnecessary wear on equipment.

The following guidelines shall be followed whenever deadheading becomes absolutely necessary.

# **Definition of Deadheading**

To pilot or drive a vehicle, while not performing work from one location to another on roads open to traffic.

Does not include movement within a signed work zone or signed work area.

Vehicle is not used for intended purpose during travel unless it is a licensed on-road vehicle.

**Prohibited Equipment** (Equipment that should never be deadheaded on any route)

Track equipment Over width equipment according to motor vehicle laws. Skid steer equipment Quickcut mowers Any equipment that is not road worthy

<u>Prohibited Facilities</u> (Equipment shall never be deadheaded on travel lanes of these facilities. Shoulders are acceptable if proper procedures are followed.)

Interstates High volume facilities Controlled and Limited Access Roadways and Freeways

# Procedure if you have to deadhead

Obtain approval from Crew Leader or Supervisor in charge of the operation.

Use low volume roads and back routes to job sites.

A Shadow Vehicle shall be used whenever you are on a multi-lane highway facility or on the shoulder of the routes shown above. In all other situations a Shadow Vehicle should be used when practical.

If you are not using a shadow vehicle, the use of flashing strobes and other lights might distract other drivers from seeing your brake lights, headlights and turn signals when you are travelling to your destination.

Use of these devices should be restricted to travel speed that is substantially less (25 mph less than posted or prevailing speed). All indicator signals shall be functioning properly.

Warning Triangles for slow moving vehicles should be in place.

Use Equipment "Road" Gear for more appropriate vehicle speed.

#### When Permitted

Time of day (allowed only during daylight hours) Weather events and emergencies.

# **Driving Tips**

Utilize Defensive driving techniques, not an aggressive driving attitude.

If traffic backs up behind deadheading equipment, pull to safe area occasionally and allow traffic to pass.

If you have to deadhead, then pay particular attention to the surrounding traffic (both on-coming and the traffic behind you). When you are turning across the road in a slower piece of machinery do not turn until you are clear of all on-coming vehicles AND you are sure that all the vehicles behind you are stopping AND that they are aware you are turning,

#### Implementation

Guidelines should be reviewed with each operator and incorporated into orientation.

Each employee will be held accountable for his or her actions. If any employee fails to abide by the above deadheading guidelines, disciplinary action will be followed in accordance with our Workplace Safety Manual.

Liquidated Damages for failure to comply with the above Deadheading Guidelines are Ten Thousand Dollars (\$10,000.00) per event.

## **COOPERATION WITH STATE FORCES AND OTHER CONTRACTORS**

The Contractor must cooperate with State forces and other Contractors working within the limits of this project as directed by the Engineer.

## PRESERVATION OF PROPERTY

The Contractor shall exercise care to avoid damage to all public and private property and facilities. Any damage to properties, such as, but not limited to, mailboxes, fences, gates, vehicles, driveways, etc. shall immediately be restored to the previously existing condition by the contractor. No payment will be made to the Contractor for such restorative work.

# DAMAGE TO EXISTING PAVEMENT

In addition to the requirements of the *Standard Specifications* concerning this subject, the contractor is cautioned that he will be held responsible for all damages to the pavement, base, and subgrade caused by his operations; including, but not limited to, rutting, and shoving of the existing pavement and yielding or rutting of the existing base and subgrade.

Any damage to the pavement caused by the Contractor's operations will be repaired by the Contractor at no cost to the department.

#### DRIVEWAY ACCESS

The Contractor shall maintain access to driveways for all residents and property owners throughout the life of the project.

The Contractor shall not perform work for private citizens or agencies in conjunction with this project or within the project limits of this contract. Any driveway to be paved by the Contractor, which ties into a NCDOT system road being paved by the Contractor, must be paved either prior to the road paving project or after its completion.

# **TRAFFIC SIGNS & MAILBOXES**

Permanent traffic signs and mailboxes that interfere with the tree / brush cutting operations are to be removed during the course of a day's work and be re-installed at the conclusion of each workday. The contractor shall mark the proper location of the signs and mailboxes by placing an offset stake behind the ditch line to ensure proper replacement.

Open burning is not permitted on any portion of the right-of-way limits established for this project. Do not burn the clearing, grubbing or demolition debris designated for disposal and generated from the project at locations within the project limits, off the project limits or at any waste or borrow sites in this county. Dispose of the clearing, grubbing and demolition debris by means other than burning, according to state or local rules and regulations.

# HAZARDOUS, CONTAMINATED, AND/OR TOXIC MATERIAL:

When the Contractor's operations encounter or expose any abnormal condition which may indicate the presence of a hazardous, contaminated, and/or toxic material, such operations shall be discontinued in the vicinity of the abnormal condition and the Engineer shall be notified immediately.

# TRAFFIC CONTROL AND WORK ZONE SAFETY

(On Call - Div. 12)

The Contractor shall maintain traffic during construction and provide, install, maintain and remove all traffic control devices in accordance with the Project Special Provisions, the most current edition of the <u>Standard Specifications for Roads and Structures</u>, <u>NCDOT Standard</u> <u>Drawings</u> and the <u>Manual of Uniform Traffic Control Devices</u> (MUTCD).

The Contractor performing the work zone traffic control shall have a minimum of one (1) NCDOT Certified Work Zone Supervisor and one (1) NCDOT Certified Work Zone Installer in accordance with Section 1101 of the Standard Specifications. For information on how to become a Certified Work Zone Supervisor or Installer please go to: <a href="https://connect.ncdot.gov/projects/WZTC/Pages/Training.aspx">https://connect.ncdot.gov/projects/WZTC/Pages/Training.aspx</a>

The Contractor shall abide by all traffic control regulations and maintain an open, safe lane of traffic at all times for the traveling public with the necessary flagmen and or pilot vehicle as the job deems necessary with the approval of the Engineer. The Contractor must maintain service to all businesses during their hours of operations.

The Contractor shall utilize complete and proper traffic controls and traffic control devices during all operations. All signs, traffic control, and traffic control devices required for any operation shall be functional and in place prior to the commencement of that operation. Signs for temporary operations shall be removed during periods of inactivity. The Contractor is required to leave the project in a manner that will be safe to the traveling public and which will not impede motorists.

Work Zone & Work Zone Advanced Warning Signs will be required (refer to Roadway Standard Drawing 1101.01). Portable signs may be used on this project. The portable work zone signs shall be 48"x 48" black on orange signs and must meet or exceed the requirements of NCHRP 350 for Work Zone Category II Devices. Use portable work zone signs and stands specifically

designed for one another. Roadway to sign mounting height shall be 5 feet minimum off the ground (refer to Roadway Standard Drawing 1110.02). Signs shall be either composite, aluminum, or retroreflective roll-up (Non-reflective Mesh Signs will not be accepted). Portable work zone signs shall be mounted 3' minimum from travel lane on the right shoulder or in the median to maintain a work zone of 2-mile maximum length. Shoulder and median signing will be required for Divided Facilities. Additional signs should be placed at intersections and interchanges where traffic is entering the work area. Care should be taken that these signs are displayed only while work is underway. Any nighttime work shall be approved by the Engineer and shall comply with the requirements of Article 105-14 of the Standard Specifications.

The Contractors equipment shall not be parked within the highway right of way overnight or at other times of inactivity unless approved by the Engineer and in no case within 30 feet of the edge of the travel lane.

When personnel and equipment are working within a lane of travel of **any roadway** facility, close the open travel lane according to *Roadway Standard Drawings* No. 1101.02 or as directed by the Engineer. Conduct the work so that all personnel and equipment remain within the closed travel lane.

When personnel and equipment are working on the shoulder adjacent to **any roadway** facility **less than 5 feet** from an open travel lane, close the nearest open travel lane using the *Roadway Standard Drawings* No. 1101.02 unless the work area is protected by barrier or guardrail.

When personnel and equipment are working on the roadway shoulder adjacent to a **multi-lane or divided facility** and within **5 to 10 feet** of an open travel lane, close the nearest open travel lane using the *Roadway Standard Drawings* No. 1101.02 unless the work area is protected by barrier or guardrail.

When personnel and equipment are working on the roadway shoulder adjacent to a **multi-lane or divided facility** and within **10 to 40 feet** of an open travel lane a shoulder closure shall be required utilizing drums (refer to Roadway Standard Drawings 1101.04). A Temporary Lane Closure for any **multi-lane roadway** may be required at the discretion of the Engineer.

Do not work simultaneously on both sides of an open travel way, within the same location, on any undivided roadway. Do not perform work involving heavy equipment within 15 feet of the edge of travel way when work is being performed behind a lane closure on the opposite side of the travel way. Perform work only when weather and visibility conditions allow safe operations as directed by the Engineer.

Traffic movements through lane closures on roads with two-way traffic shall be controlled by flaggers stationed at each end of the work zone. In situations where sight distance is limited, the Contractor shall provide additional means of controlling traffic, including, but not limited to, two-way radios, pilot vehicles, or additional flaggers. Flaggers shall be competent personnel, adequately trained in flagging procedures, and furnished with proper safety devices and equipment, including, but not limited to safety vests, hard hats, and stop/slow paddles (refer to *Roadway Standard Drawing 1150.01*).

All personnel when working in traffic areas or areas in close proximity to traffic shall wear an approved safety vest which meets the most current reflectivity standards and the color requirements of the <u>Manual of Uniform Traffic Control Devices</u> (MUTCD).

The Contractor shall comply with all applicable Federal, State, and local laws, ordinances, and regulations governing safety, health, and sanitation, and shall provide all safeguards, safety devices, and protective equipment, and shall take any other needed actions, on his own responsibility that are reasonably necessary to protect the life and health of employees on the job and the safety of the public, and to protect property in connection with the performance of the work covered by the contract.

Failure to comply with any of the requirements for safety and traffic control as specified in this contract shall result in suspension of work as provided in Subarticle 108-7(2) of the 2024 *Standard Specifications*.

No separate or direct payment will be made for supplying traffic control, traffic control devices, flagging, or signing as all such labor and materials will be considered incidental to the various traffic control items included in this contract.

Provide the service of at least one qualified work zone installer during the setup, installation, and removal of temporary traffic control within the highway right of way. The qualified work zone installer shall serve as crew leader and shall be on site and directing the installation and removal of temporary traffic control. If multiple temporary traffic control installations or removals are occurring simultaneously, then each shall have a qualified work zone installer.

The work zone installer shall be qualified by an NCDOT approved training agency in the safe and competent set up of temporary traffic control. For a complete listing of approved training agencies, see the Work Zone Safety Training webpage.

A work zone supervisor, in accordance with Article 1101-13 of the *Standard Specifications*, may fulfill the role of the work zone installer during the setup, installation, and removal of temporary traffic control within the highway right of way provided they are on site and directing the installation and removal of temporary traffic control.

All other individuals participating in the setup, installation, and removal of temporary traffic control within the highway right of way shall be certified as a qualified flagger in accordance with Article 1150-3 of the *Standard Specifications*, even if flagging is not being performed as part of the traffic control.

Provide the name and contact information of all qualified work zone installers to the Engineer prior to or at the preconstruction conference. Additionally, provide a qualification statement that all other individuals participating in the setup, installation, and removal of temporary traffic control are qualified flaggers that have been properly trained through an NCDOT approved training agency.

Payment for transportation project work performed pursuant to contract in any fiscal year other than the current fiscal year is subject to appropriations by the General Assembly. Transportation project contracts shall contain a schedule of estimated completion progress, and any acceleration of this progress shall be subject to the approval of the Department of Transportation provided funds are available. The State reserves the right to terminate or suspend any transportation project contract, and any transportation project contract shall be so terminated or suspended if funds will not be available for payment of the work to be performed during that fiscal year pursuant to the contract. In the event of termination of any contract, the contractor shall be given a written notice of termination at least 60 days before completion of scheduled work for which funds are available. In the event of termination, the contractor shall be paid for the work already performed in accordance with the contract specifications.

Payment will be made on any contract terminated pursuant to the special provision in accordance with Subarticle 108-13(D) of the *Standard Specifications*.

(b) Nondiscrimination

The contractor, with regard to the work performed by it during the contract, shall not discriminate on the grounds of race, color, or national origin in the selection and retention of subcontractors, including procurements of materials and leases of equipment. The contractor shall not participate directly or indirectly in the discrimination prohibited by the Acts and the Regulations, including employment practices when the contract covers any activity, project, or program set forth in Appendix B of 49 CFR Part 21.

(c) Solicitations for Subcontractors, Including Procurements of Materials and Equipment

In all solicitations, either by competitive bidding, or negotiation made by the contractor for work to be performed under a subcontract, including procurements of materials, or leases of equipment, each potential subcontractor or supplier shall be notified by the contractor of the contractor's obligations under this contract and the Acts and the Regulations relative to Nondiscrimination on the grounds of race, color, or national origin.

(d) Information and Reports

The contractor shall provide all information and reports required by the Acts, the Regulations, and directives issued pursuant thereto and shall permit access to its books,

records, accounts, other sources of information, and its facilities as may be determined by the Recipient or the FHWA to be pertinent to ascertain compliance with such Acts, Regulations, and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish the information, the contractor shall so certify to the Recipient or the FHWA, as appropriate, and shall set forth what efforts it has made to obtain the information.

(e) Sanctions for Noncompliance:

In the event of a contractor's noncompliance with the Non-discrimination provisions of this contract, the Recipient will impose such contract sanctions as it and/or the FHWA may determine to be appropriate, including, but not limited to:

- (i) Withholding payments to the contractor under the contract until the contractor complies; and/or
- (ii) Cancelling, terminating, or suspending a contract, in whole or in part.
- (f) Incorporation of Provisions

The contractor shall include the provisions of paragraphs (a) through (f) in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Acts, the Regulations and directives issued pursuant thereto. The contractor shall take action with respect to any subcontract or procurement as the Recipient or the FHWA may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, that if the contractor becomes involved in, or is threatened with litigation by a subcontractor, or supplier because of such direction, the contractor may request the Recipient to enter into any litigation to protect the interests of the Recipient. In addition, the contractor may request the United States to enter into the litigation to protect the interests of the United States.

#### (2) Title VI Nondiscrimination Program (23 CFR 200.5(p))

In accordance with other related nondiscrimination authorities, bidders and contractors will also not be discriminated against on the grounds of sex, age, disability, low-income level, creed/religion, or limited English proficiency in consideration for an award."

- 4. Physically incorporate the FHWA-1273, in its entirety, into all subcontracts and subsequent lower tier subcontracts on Federal-aid highway construction contracts only.
- 5. Provide language assistance services (i.e., written translation and oral interpretation), free of charge, to LEP employees and applicants. Contact NCDOT OCR for further assistance, if needed.
- 6. For assistance with these Title VI requirements, contact the NCDOT Title VI Nondiscrimination Program at 1-800-522-0453.

#### **ON-THE-JOB TRAINING**

(10-16-07) (Rev. 4-21-15)

#### Description

The North Carolina Department of Transportation will administer a custom version of the Federal On-the-Job Training (OJT) Program, commonly referred to as the Alternate OJT Program. All contractors (existing and newcomers) will be automatically placed in the Alternate Program. Standard OJT requirements typically associated with individual projects will no longer be applied at the project level. Instead, these requirements will be applicable on an annual basis for each contractor administered by the OJT Program Manager.

On the Job Training shall meet the requirements of 23 CFR 230.107 (b), 23 USC – Section 140, this provision and the On-the-Job Training Program Manual.

The Alternate OJT Program will allow a contractor to train employees on Federal, State and privately funded projects located in North Carolina. However, priority shall be given to training employees on NCDOT Federal-Aid funded projects.

#### Minorities and Women

Developing, training and upgrading of minorities and women toward journeyman level status is a primary objective of this special training provision. Accordingly, the Contractor shall make every effort to enroll minority and women as trainees to the extent that such persons are available within a reasonable area of recruitment. This training commitment is not intended, and shall not be used, to discriminate against any applicant for training, whether a member of a minority group or not.

#### **Assigning Training Goals**

The Department, through the OJT Program Manager, will assign training goals for a calendar year based on the contractors' past three years' activity and the contractors' anticipated upcoming year's activity with the Department. At the beginning of each year, all contractors eligible will be contacted by the Department to determine the number of trainees that will be assigned for the upcoming calendar year. At that time the Contractor shall enter into an agreement with the Department to provide a self-imposed on-the-job training program for the calendar year. This agreement will include a specific number of annual training goals agreed to by both parties. The number of training assignments may range from 1 to 15 per contractor per calendar year. The Contractor shall sign an agreement to fulfill their annual goal for the year.

## **Training Classifications**

The Contractor shall provide on-the-job training aimed at developing full journeyman level workers in the construction craft/operator positions. Preference shall be given to providing training in the following skilled work classifications:

Equipment Operators Truck Drivers Carpenters Concrete Finishers Pipe Layers Office Engineers Estimators Iron / Reinforcing Steel Workers Mechanics Welders

The Department has established common training classifications and their respective training requirements that may be used by the contractors. However, the classifications established are not all-inclusive. Where the training is oriented toward construction applications, training will be allowed in lower-level management positions such as office engineers and estimators. Contractors shall submit new classifications for specific job functions that their employees are performing. The Department will review and recommend for acceptance to FHWA the new classifications proposed by contractors, if applicable. New classifications shall meet the following requirements:

Proposed training classifications are reasonable and realistic based on the job skill classification needs, and

The number of training hours specified in the training classification is consistent with common practices and provides enough time for the trainee to obtain journeyman level status.

The Contractor may allow trainees to be trained by a subcontractor provided that the Contractor retains primary responsibility for meeting the training and this provision is made applicable to the subcontract. However, only the Contractor will receive credit towards the annual goal for the trainee.

Where feasible, 25 percent of apprentices or trainees in each occupation shall be in their first year of apprenticeship or training. The number of trainees shall be distributed among the work classifications on the basis of the contractor's needs and the availability of journeymen in the various classifications within a reasonable area of recruitment.

No employee shall be employed as a trainee in any classification in which they have successfully completed a training course leading to journeyman level status or in which they have been employed as a journeyman.

## **Records and Reports**

The Contractor shall maintain enrollment, monthly and completion reports documenting company compliance under these contract documents. These documents and any other information as requested shall be submitted to the OJT Program Manager.

Upon completion and graduation of the program, the Contractor shall provide each trainee with a certification Certificate showing the type and length of training satisfactorily completed.

## **Trainee Interviews**

All trainees enrolled in the program will receive an initial and Trainee/Post graduate interview conducted by the OJT program staff.

## Trainee Wages

Contractors shall compensate trainees on a graduating pay scale based upon a percentage of the prevailing minimum journeyman wages (Davis-Bacon Act). Minimum pay shall be as follows:

60 percent	of the journeyman wage for the first half of the training period
75 percent	of the journeyman wage for the third quarter of the training period
90 percent	of the journeyman wage for the last quarter of the training period

In no instance shall a trainee be paid less than the local minimum wage. The Contractor shall adhere to the minimum hourly wage rate that will satisfy both the NC Department of Labor (NCDOL) and the Department.

## Achieving or Failing to Meet Training Goals

The Contractor will be credited for each trainee employed by him on the contract work who is currently enrolled or becomes enrolled in an approved program and who receives training for at least 50 percent of the specific program requirement. Trainees will be allowed to be transferred between projects if required by the Contractor's scheduled workload to meet training goals.

If a contractor fails to attain their training assignments for the calendar year, they may be taken off the NCDOT's Bidders List.

## Measurement and Payment

No compensation will be made for providing required training in accordance with these contract documents.

## **DEBARMENT CERTIFICATION**
