In addition, your attention is directed to Articles 107-16, 108-1, 108-2 and 108-3 of the Standard Specifications relative to liability insurance, prosecution of work, progress schedule and preconstruction conference. Information regarding these items and other items is available at https://connect.ncdot.gov/projects/construction/Pages/Construction-Manual.aspx and should be addressed prior to beginning work. Please forward this information to the Division Construction Engineer, Mr. Rodney Gantt, as soon as possible so that a preconstruction conference can be held. In accordance with Article 104-2 of the Standard Specifications, it will be necessary for you to submit the name of those individuals within your organization who will be authorized to sign supplemental agreements that may be necessary in the performance of the work under this contract.
