In addition, your attention is directed to Articles 107-16, 108-1, 108-2 and 108-3 of the Standard Specifications relative to liability insurance, prosecution of work, progress schedule and preconstruction conference. Information regarding these items and other items is available at https://connect.ncdot.gov/projects/construction/Pages/Construction-Manual.aspx and should be addressed prior to beginning work. Please forward this information to the Division Construction Engineer, Mr. Rodney Gantt, as soon as possible so that a preconstruction conference can be held.
