<u>INTERMEDIATE CONTRACT TIME NUMBER (2) AND LIQUIDATED DAMAGES</u> (2-20-07) SPI G14 H

The Contractor shall complete the work required of each plant bed maintenance cycle monthly from November to February, every two weeks from March to April, weekly from May to July, every two weeks from August to September, for a total of roughly twenty-seven (27) complete cycles.

The date of availability for this intermediate contract time will be the first day of each scheduled week.

The completion date for this intermediate contract time will be the last day of each scheduled week.

The scheduled week shall be at the discretion of the engineer. The liquidated damages are One Hundred Dollars (\$ 100.00) per calendar day.

INTERMEDIATE CONTRACT TIME NUMBER (3) AND LIQUIDATED DAMAGES (2-20-07) SPI G14 H

The Engineer will direct the Contractor which beds will receive mulch. The Contractor shall complete the work required for placement of mulch in all plant bed areas as directed by the Engineer. A lane closure will be required for the placement of mulch in accordance with NCDOT Standard Specifications.

The period for placement of mulch is November 1 to March 1.

The liquidated damages are One Hundred Dollars (\$ 100.00) per calendar day.

AUTHORITY OF THE ENGINEER

The Engineer for this project shall be the Division Engineer, Division 12, Division of Highways, North Carolina Department of Transportation, acting directly or through his duly authorized representatives.

The Engineer will decide all questions which may arise as to the quality and acceptability of work performed and as to the rate of progress of the work; all questions which may arise as to the interpretation of the contract; and all questions as to the acceptable fulfillment of the contract on the part of the Contractor. His decision shall be final and he shall have executive authority to enforce and make effective such decisions and orders as the Contractor fails to carry out promptly.
