The North Carolina Department of Transportation is requesting bids for a bridge replacement which includes grading, paving, drainage, and pavement markings located on SR 1168 (Johnstown Road) in Lincoln County. The Contractor is to furnish labor, material, equipment, and traffic control.

The date of availability for this contract is **December 15, 2015**. The completion date for this contract is **November 1, 2016**.
