The meeting will begin at 3:30 p.m. promptly on the West side of the site (nearest to Sulphur Springs Rd.). **Bid Proposals will be distributed at the pre-bid meeting**. Your firm must be represented by at least one full-time employee who is authorized to do business on behalf of the company. The representative must be present for the entire meeting to be eligible to bid. All questions must be presented during the pre-bid conference as no questions will be answered post meeting.

The overall completion date of this contract will be October 31, 2021.
