Project Description: Roadway Widening and Water Line Construction

The North Carolina Department of transportation is requesting bids for roadway widening and water line construction on SR-1625 (9th Ave Dr NW) in the City of Hickory, Burke County to be let at 2:00 PM on Wednesday, January 3, 2024.

The availability date for this project is **February 12, 2024.**

The completion date for this project is October 30, 2026.

In order for prospective bidders to have extensive knowledge of the project, prospective bidders are encouraged to attend a non-mandatory pre-bid conference at 10:00 AM on Thursday December 21, 2023 at Winkler Activity Center, 2000 Clement Blvd NW, Hickory, NC 28601.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid.** Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project.**

New requirement effective all lettings June 1, 2022 and later: Bidders must be registered on the Interested Parties List to be prequalified to bid no later than one business day prior to the advertised letting date for each contract that a bid is being submitted.
