The North Carolina Department of transportation is requesting bids for roadway widening and water line construction on SR-1625 (9th Ave Dr NW) in the City of Hickory, Burke County to be let at 2:00 PM on Wednesday, January 3, 2024.

The availability date for this project is **February 12, 2024**.

The completion date for this project is **October 30, 2026**.

**In order for prospective bidders to have extensive knowledge of the project, prospective bidders are encouraged to attend a non-mandatory pre-bid conference at 10:00 AM on Thursday December 21, 2023 at Winkler Activity Center, 2000 Clement Blvd NW, Hickory , NC 28601.**

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
