## **NOTICE TO PROSPECTIVE BIDDERS**

Subject: Invitation to Bid on Purchase Order Contract DM00469.

County: Buncombe

Project Description: Tree Clearing Along New Access Road Connecting I-26 Interchange to NC 191 (Brevard Rd)

The North Carolina Department of Transportation is requesting bids for tree clearing along new access road connecting I-26 interchange to NC 191 (Brevard Rd) in Buncombe County to be let at 2:00 PM on Wednesday, January 29, 2025.

The availability date for this project is February 12, 2025.

The completion date for this project is **June 13, 2025.** 

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid.** Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project.** 

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
