Project Description: Helene – Permanent Roadway and Structure Repairs to Bridge #990043 and Bridge #9900328 on US-19E over South Toe River

The North Carolina Department of Transportation is requesting bids for permanent roadway and structure repairs to bridge #990043 and bridge #9900328 on US-19E over South Toe River in Yancey County to be let at 2:00 PM on Wednesday, February 4, 2026.

The availability date for this project is **March 16, 2026**.

The completion date for this project is **June 26, 2026**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
