NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Purchase Order Contract DM00308.

County: Buncombe

Project Description: Drainage and Sinkhole Repair

The North Carolina Department of Transportation is requesting bids for drainage and sinkhole repair on eastbound I-240 approximately 150 feet west of Central Avenue in the City of Asheville, Buncombe County to be let at 2:00 PM on Wednesday, February 17, 2021.

The availability date for this project is March 22, 2021.

The completion date for this project is August 21, 2021.

In order for all prospective bidders to have an extensive knowledge of the project, all prospective bidders shall attend a mandatory pre-bid conference on Thursday February 11, 2021 at 1:00 PM on site at Four Points Hotel Central Avenue parking lot, Asheville, NC 28801 as described in the proposal.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid.** Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project.**
