Project Description: Intersection Improvements

The North Carolina Department of Transportation is requesting bids intersection improvements at US-25 (Hendersonville Rd) and SR-3503 (Overlook Rd) in Buncombe County to be let at 2:00 PM on Wednesday, March 2, 2022.

The availability date for this project is **April 11, 2022**.

The completion date for this project is **May 12, 2023**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
