The North Carolina Department of Transportation is requesting bids for providing hauling equipment upon request at various locations on interstate, primary, and secondary routes in Buncombe County to be let at 2:00 PM on Wednesday, March 5, 2025.

The completion date for this contract is **April 13, 2026**.

Sealed bids must be received in the NC Department of Transportation Division Office at 55 Orange Street, Asheville, NC 28801 by 2:00 p.m. on Wednesday, March 5, 2025. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
