The meeting was conducted by Mr. Christopher A. Guffey, District Engineer, and Mr. Dean Hardister, Western Regional Operations Engineer, with the following items being discussed.

- ❖ Mr. Guffey opened the meeting, welcoming everyone and asked that each person introduce themselves.
- ❖ Mr. Guffey asked Dean Hardister from the NCDOT Geotechnical Unit to talk about the wall and micro-pile specifications.
- ❖ Mr. Hardister described the situation with the existing wall deterioration and presented what the Department had designed for the new wall.
- ❖ Mr. Hardister explained the purpose of the line items along with the lengths and sums of quantities.
- ❖ Mr. Guffey explained that there would be time restrictions for Lane Closures during this project as follows;

Monday – Sunday, 9:00 A.M.-2:00 P.M. and 6:00 P.M. – 6:00 A.M.

During Lane Closure Operations flaggers shall be placed at the top and bottom of the mountain, and a Pilot Vehicle shall be used.

Compaction Grouting shall be performed at night with the use of a Lane Closure.

Traffic Control shall be incidental to the line items in the contract.

- ❖ Mr. Guffey explained Erosion Control for the contract, making note of the plans in the contract documents and line items that pertained to such.
- ❖ Discussion was held about a Construction Entrance. It was decided that additional line items would be added to the contract bid page.

Line items added for construction entrance will be as follows;

Geotextile for Drainage, Type 2

Erosion Control Stone A

Discussion was held in reference to seeding and mulching for erosion control. It was decided that line items for Seeding and Mulching, permanent and temporary, be added to the contract.

The following line items will be added to the contract for Seeding and Mulching;

Temporary Mulching

Seed for Temporary Seeding

Fertilizer for Temporary Seeding

Seeding and Mulching

- ❖ Mr. Guffey noted that if any further question should arise, the contractor shall notify NCDOT by Friday March 1, 2019, so that the issue could be addressed, and all perspective bidders notified of such.
- ❖ With no further discussion the meeting was adjourned.
