PROJECT DESCRIPTION: The North Carolina Department of Transportation is seeking the services of a Licensed Landscape Contractor/Grounds Maintenance Company to maintain a Pre-established Ornamental Landscape Planting. The work shall include: Litter and debris pick-up; Mowing and line/blade trimming; Post-emergence and pre-emergence herbicide treatment; Hand pulling of various grasses and broadleaf weeds; Plant bed repair; Removal of dead plant material; Pruning of native grasses; and Removal and off-site disposal of clipping debris.

The date of availability for this contract is April 10, 2017.

The completion date for this contract is October 31, 2017.
