Project Description: Guardrail Installation and Replacement Along SR-1318 (Guntertown Rd) and SR-1316 (Chapel Hill Rd)

The North Carolina Department of Transportation is requesting bids for guardrail installation and replacement along SR-1318 (Guntertown Rd) and SR-1316 (Chapel Hill Rd) from NC-208 to NC-212 in Madison County to be let on Wednesday, March 17, 2021.

The availability date for this project is **April 26, 2021**.

The completion date for this project is **August 28, 2021**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
