Project Description: Replacement of Bridge Numbers 37, 143, 379, and 26.

The North Carolina Department of Transportation is requesting bids for replacement of bridge 37 on SR-2786 (Morgan Hill Rd), bridge 143 on SR-2027 (Martin Creek Rd), bridge 379 on SR-1003 (Paint Creek Rd), and bridge 26 on SR-1384 (South Turkey Creek Rd) in Buncombe County.

The availability date for this project is **April 15, 2019**.

The completion date for this project is **December 30, 2020**.

Bids for this project must be submitted electronically using the on-line system Bid Express®. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
