The North Carolina Department of Transportation is requesting bids for bridge repair, curb & gutter, and paving on bridges 990043, 990328, and 990056 over the South Toe River along US 19E and NC 80 in Yancey County to be let at 2:00 PM on Wednesday, April 15, 2026.

The availability date for this project is **May 25, 2026**.

The completion date for this project is **November 20, 2026**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
