Project Description: Paving and Construction of Concrete Curb and Gutter and Concrete Sidewalk

The North Carolina Department of Transportation is requesting bids for paving and construction of concrete curb and gutter and concrete sidewalk for the extension of SR-3684 (Walk Off Way) from future Enka Heritage Road to the end of existing SR-3684 in Buncombe County to be let at 2:00 PM on Wednesday, May 5, 2021.

The availability date for this project is **June 7, 2021**.

The completion date for this project is **October 30, 2021**.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
