The North Carolina Department of Transportation is requesting bids for sweeping, debris removal, and drainage structure clean out on various interstate, primary, and secondary routes in Burke, McDowell, Mitchell, and Rutherford Counties.

The availability date for this renewable contract is June 16, 2025.

The completion date for this renewable contract is **June 15, 2026**.

Sealed bids must be received in the NC Department of Transportation Division Office at 55 Orange Street, Asheville, NC 28801 by 2:00 p.m. on Wednesday, May 7, 2025. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
