The North Carolina Department of Transportation is requesting bids to replace bridge 19 over Cove Creek on SR-1143 (Tight Run Rd) in McDowell County.

The completion date for this project is **June 13, 2020**.

Bids for this project must be submitted electronically using the on-line system Bid Express®. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
