Subject: Invitation to Bid on Purchase Order Contract DM00321.

County: Madison

Project Description: Milling, Patching, Resurfacing, and Shoulder Reconstruction

The North Carolina Department of Transportation is requesting bids for milling, patching, resurfacing, and shoulder reconstruction on SR-1395 (Walnut Creek Rd) from SR-1390 (Fisher Ln) north 6.08 miles in Madison County to be let at 2:00 PM on Wednesday, May 19, 2021.

The availability date for this project is **July 1, 2021**.

The completion date for this project is **December 10, 2022**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
