Project Description: Construction of a New Access Road into the Burke Industrial Park

The North Carolina Department of Transportation is requesting bids for the construction of a new access road into the Burk Industrial Park located just off I-40 Exit 96 (Kathy Road) in Burke County to be let at 2:00 PM on Wednesday, May 21, 2025.

The completion date for this contract is **June 30, 2026**.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
