The North Carolina Department of Transportation is requesting bids for pavement repairs and overlays upon request at various locations on interstate, primary, and secondary routes in Buncombe, Madison, and Yancey Counties.

Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
