Subject: Invitation to Bid on Purchase Order Contract DM00285.

County: Buncombe

Project Description: Concrete Pavement and Concrete Bridge Deck Repair on I-40.

The North Carolina Department of Transportation is requesting bids for concrete pavement and concrete bridge deck repair on I-40 from west of exit 44 to west of I-26/240 in Buncombe County.

The completion date for this project is **December 14, 2019**.

Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
