## NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Purchase Order Contract DM00246.

County: Buncombe

Project Description: Grading, Paving, Drainage, and Signals.

The North Carolina Department of Transportation is requesting bids for grading, paving, drainage, and signals at the intersection of US-19/23/74A and NC-63 (New Leicester Highway) in Buncombe County.

The availability date for this project is July 9, 2018.

The completion date for this project is **December 15, 2018.** 

## Bids for this project must be submitted electronically using the on-line system Bid Express<sup>®</sup>. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
