Project Description: Bridge Rehabilitation and Latex Modified Concrete Overlays on Buncombe Bridge #100295 and Madison Bridge #560528

The North Carolina Department of Transportation is requesting bids for the rehabilitation and latex modified concrete overlay on Buncombe bridge #100295 on SR 1224 (Monte Vista Rd) over I-40 and Madison bridge #560528 over Ivey Creek on US 25 to be let at 2:00 PM on Wednesday, July 16, 2025.

The availability date for this project is **August 25, 2025**.

The completion date for this project is **October 15, 2026**.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
