Project Description: Latex Modified Concrete – Very Early Strength (LMC-VES) Overlay and Joint Repair

The North Carolina Department of Transportation is requesting bids for latex modified concrete – very early strength (LMC-VES) overlay and joint repair on bridge numbers 100284, 100289, 100302, and 100303 on US-19/23/70 (Future I-26) in Buncombe County to be let at 2:00 PM on Wednesday, July 21, 2021.

The availability date for this project is **August 30, 2021**.

The completion date for this project is **November 30, 2021**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
