The North Carolina Department of Transportation is requesting bids to replace bridge 29 over Webbs Creek on SR-1983 (Pilgrim Rd) in Rutherford County.

The completion date for this project is **August 29, 2020.**

Bids for this project must be submitted electronically using the on-line system Bid Express®. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid.** Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project.**
