Subject: Invitation to Bid on Purchase Order Contract DM00258.

County: Buncombe, McDowell, and Rutherford.

Project Description: Install Long Line Pavement Markings.

The North Carolina Department of Transportation is requesting bids to install long line pavement markings on SR-1756, SR-1001, and SR-1006 in Buncombe, McDowell, and Rutherford counties.

The availability date for this project is **September 12, 2018**.

The completion date for this project is **June 28, 2019**.

**Bids for this project must be submitted electronically using the on-line system Bid Express®. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.
