NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Purchase Order Contract DM00261.

County: Madison

Project Description: Guardrail Installation.

The North Carolina Department of Transportation is requesting bids for guardrail installation on SR-1143 (Upper Brush Creek Road) from Brush Creek School Road to Bridge 148 in Madison County.

The availability date for this project is **September 12, 2018.**

The completion date for this project is November 30, 2018.

Bids for this project must be submitted electronically using the on-line system Bid Express[®]. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning</u> work on the project.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
