County: Buncombe, Burke, Madison, McDowell, Rutherford, and Yancey

Project Description: Installation of Long-Life Pavement Markings

The North Carolina Department of Transportation is requesting bids for installation of long-life pavement markings on various primary and secondary routes in Buncombe, Burke, Madison, McDowell, Rutherford, and Yancey counties to be let at 2:00 PM on Wednesday, August 18, 2021.

The availability date for this project is **September 27, 2021**.

The completion date for this project is **July 31, 2022**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
