The North Carolina Department of Public Safety Emergency Management Division and the Department of Transportation are requesting bids for the construction of DBB Bridges on private roads over the Cane River at 187 Sweet Birch Lane and 148 South Face Lane in Yancey County to be let at 2:00 PM on Wednesday, August 19, 2026.

The date of availability for bridge construction at site 100-01-00205 (187 Sweet Birch Lane) is the date the Contractor begins work, but not before September 9, 2026 and no later than December 3, 2026.

The completion date for this contract is the date that is two hundred ten (210) consecutive calendar days after and including the date of availability.

The date of availability for bridge construction at site 100-01-00202(148 South Face Lane) is the date the Contractor begins work, but not before September 9, 2026 and no later than February 2, 2027.

The completion date for this contract is the date that is two hundred ten (210) consecutive calendar days after and including the date of availability.
