Project Description: Landscape Development/Corridor Renovations And Improvements

The North Carolina Department of Transportation is requesting bids for landscape development/corridor renovations and improvements on NC-213 (Carl Eller Rd) from SR-1609 (Main St) to SR 1549 (Calvin Edney Rd) in Madison County to be let at 2:00 PM on Wednesday, August 28, 2024.

The availability date for this project is **October 15, 2024**.

The completion date for this project is **September 30, 2026**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
