Project Description: Permanent Repairs to Bridge 100258 Over Swannanoa River on US-70 and Bridge 100504 Over US-74/I-240 Ramp on I-240 EB.

The North Carolina Department of Transportation is requesting bids for permanent repairs to bridge 100258 over Swannanoa River on US-70 and bridge 100504 over US-74/I-240 Ramp on I-240 EB in Buncombe County to be let at 2:00 PM on Wednesday, September 16, 2026.

The availability date for this project is **October 26, 2026**.

The completion date for this project is **February 23, 2027**.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
