Project Description: Helene Relief – Construction of Standard and Modular Bridge Replacements at:

- 11456 Big Laurel Rd, Marshall
- 303 Young Cove Rd, Bakersville

The North Carolina Department of Public Safety Emergency Management Division and the Department of Transportation are requesting bids for the construction of modular and standard bridges on private roads over Big Laurel Creek at 11456 Big Laurel Rd, Marshall in Madison County and over Young Cove Creek at 303 Young Cover Rd, Bakersville in Mitchell County to be let at 2:00 PM on Wednesday, September 16, 2026.

The **date of availability** for bridge construction at Site 057-01-b1b42 (Big Laurel Cove Rd) is the date the Contractor begins work, but not before October 18, 2026 and no later than July 2, 2027.
