NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Purchase Order Contract DM00434.

County: Buncombe

Project Description: Pedestrian Improvements and Concrete Curb Ramp Upgrades

The North Carolina Department of Transportation is requesting bids for pedestrian improvements and concrete curb ramp upgrades along US-25 (Hendersonville Rd) from the intersection of Walnut St to NC-146 (Long Shoals Rd) in Buncombe County to be let at 2:00 PM on Wednesday, September 18, 2024.

The availability date for this project is **October 28, 2024.**

The completion date for this project is October 30, 2026.

In order for all prospective bidders to have an extensive knowledge of the project, all prospective bidders shall attend a mandatory pre-bid conference on Thursday September 5, 2024 at 8:30 AM at the Division 13 Office located at 55 Orange Street, Asheville, NC 28801 as described in the proposal.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid.** Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project.**

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:

New requirement effective all lettings June 1, 2022 and later: Bidders must be registered on the Interested Parties List to be prequalified to bid no later than one business day prior to the advertised letting date for each contract that a bid is being submitted.
